Proposal:

In the academic year 2018-19 and the previous years, a proposal to allow the students admitted to under-graduate and post-graduate degrees (under the semester and annual system) who have passed the specified time limit to complete the degree, to take an additional one-time examination, was passed by the Vidya Vishayak Parishad meeting, was presented for consideration.

In the academic council meeting, the examination department has no objection for the students after the academic year 2014-15 to take the exams in their failed subjects and it will be difficult for the old students of the previous academic year 2014-15 to prepare individual question paper. The Chancellor (Evaluation) expressed the opinion that the students have to take the exams under the current syllabus and by registering the failed students and preparing a list of the subjects in which they have failed and according to that, in order to allow the failed students to practice under the revised syllabus, Equivalence of Subjects has to be fixed. He brought to the attention of the meeting the fact that there is a need for a period of 6 months.

While discussing the matter, thousands of students/their parents who have not cleared the exams who have been admitted to various degree courses in the years prior to 2018-19 are visiting the university every day and requesting to be allowed to write the exams and since the number of such students is increasing day by day and already the new National Education Policy (NEP) -2020) as per the updated syllabus from the academic year 2021-22

The meeting of the Academic Council noted the need to enable old

students to complete their graduation in force.

Keeping in view the University Grants Aid Commission's Guidelines on Determination ಮಾರ್ಗಸೂಚಿಯನ್ನು of a Uniform Span Period within which a Student may be allowed to Qualify for a Degree, the Vidyavishayak Parishad, as empowered by section 31 of the Karnataka State Universities Act, 2000, keeping in mind the academic and industrial interests of the students, may conduct examinations for students who have failed. It was discussed at length in the Vidyavishayak Parishad meeting about providing an opportunity to take and pass.

In the background of the points outlined in the proposal, as per the resolution of the Special Syndicate Meeting held on Date: 20.02.2024 and the Resolutions of the Special Academic Council held on Date: 26.02.2024, admitted from the academic year 2014-15 (from the year of implementation of CBCS system) of various departments of study and affiliated (It is hereby ordered that failed students in affiliated)/autonomous colleges will be given a 'one time opportunity' to write the examinations immediately. For the said students, the 1st, 3rd, 5th and 7th semesters_exams_(Under-Graduate)_will_be_held_in:November/December_2024, the 1st and 3rd semesters of Post-Graduate will be held in September and October 2024 and the 2nd semesters will be held in June/July 2025. , 4th, 6th and 8th Semester Examinations (Under-Graduate)/February/March 2025 The Chancellor (Evaluation) has been ordered to issue an official examination notification for conducting the 2nd and 4th semester examinations of Post-Graduate.

2. Further, even for the students who got admissions in previous academic year 2014-15 i.e. 2013-14 and all previous academic years i.e. Semester/Annual Examination. They are allowed to write the exam as a one-time opportunity in the subjects they failed. 2013-14 and earlier students who have failed in the examination in the academic lines should first register the failed subjects and their names compulsorily online. 1, 3, 5 and 7th Semesters UG Examinations in November/December 2024/2025 and 2nd, 4th, 6th and 8th Semesters in June/July/August 2025 considering parallel subjects for failed subjects with opinion of Deans/Experts The Vice-Chancellor (Mau) has been ordered to issue an official order to conduct the graduation examinations and 1,3 semesters of Post Graduate (PG) semester examinations.

- 3. Above order no. Except for the academic streams mentioned in 1 and 2, all the old students (including those admitted under Post Office and Directorate of Distance Education) who have failed in various Undergraduate (UG) and Post Graduate (PG) courses under the Annual Scheme in all the previous academic streams will receive 'one Provision is made for writing the examinations under the time limit. The Vice-Chancellor (Evaluation) has ordered to conduct examinations separately for the said students. Such students also have to register and apply for the failed subjects online. The Vice-Chancellor (Evaluation) has been authorized to conduct examinations as mentioned in Part-II of the Order with the opinion of Deans/Experts in parallel subjects for the failed subjects of the students as applied for. The said order is applicable to all students coming under Arts, Science, Commerce, Law and Engineering institutions. The failed Undergraduate (UG) and Postgraduate (PG) students in the autonomous colleges under the University have been ordered to appear for the 'one time opportunity' examinations by the principals of the respective autonomous colleges in November/December 2024 or when conducting the examinations for the students of the existing students of the college.
 - 4. At present, the Principals of the colleges affiliated to Bangalore University till the academic year 2017-18 under Bangalore City University and Bangalore North University are requested to give wide publicity about this order to enable all the old students who have failed in their colleges to take the proposed one-time examinations.
 - 5. Further, it is suggested that the Principals of the concerned colleges confirm the list of failed alumni who wish to take the said examinations through proper channels and submit to the Chancellor (Mau) in time.

- 6. In order to adequately/effectively implement the said decision for the old failed students, the failed subjects, payment of examination fee, equivalent subject, determination of marks for semester/yearly practices, identification of examination centers, examination ID card and all other examination related processes shall be done fully as per Part-1, Part- of the said order. 2, and authorized the Chancellor (Mau) to take necessary urgent measures to check the procedure of registration and application of students through ONLINE compulsorily as applicable to all the students mentioned in Part-3.
- 7. In this regard, the Chancellor (Evaluation) has been authorized to advertise the ONLINE LINK prominently on the official website of Bangalore University and issue press releases regularly. By order,
